# RESOLUTION ACCEPTING OFFER TO PURCHASE BOARD OWNED REAL ESTATE – BROOKFIELD VACANT LAND

Martino moved and Brennan seconded that the Brookfield Board of Education adopt the following resolution:

WHEREAS, the Board of Education is the owner of approximately 3.846 acres of vacant property (adjacent to the former high school) situated in the Township of Brookfield, County of Trumbull and State of Ohio and identified by the Brookfield County Auditor as Permanent Parcel #03-906814 (which is hereafter called the "real estate"); and

WHEREAS, the Board of Education previously determined the real estate was no longer needed for school purposes or used for school purposes, and, on March 28, 2012, the Board of Education resolved to sell the real estate by public auction pursuant to Ohio Revised Code Section 3313.41; and

**WHEREAS**, on May 12, 2012, a public auction was held and on May 22, 2012, the Board of Education rejected the highest bidder; and

**WHEREAS**, Ohio Revised Code Section 3313.41 permits a board of education to sell real or personal property at a private sale to certain enumerated public entities including a township; and

**WHEREAS,** on July 17, 2012, the Board of Trustees of the Brookfield Township expressed an interest in purchasing the property as it is adjacent to Townshipowned property; and

**WHEREAS**, no community school exists within the territory of the Board of Education of the Brookfield Local School District for which the real estate must first be made available under R.C. 3313.41(G).

**NOW, THEREFORE, BE IT RESOLVED** that the Board of Education deems it in the best interest of the Brookfield Local School District to dispose of the real estate.

**BE IT FURTHER RESOLVED** that the Board of Education finds that transferring the property to Brookfield Township Trustees to be used for a continued public purpose is in the best interests of the Brookfield School District.

**BE IT FURTHER RESOLVED** that the Board of Education authorizes the Board President, Superintendent and Treasurer to enter into a real estate purchase agreement that reflects the terms and conditions of the sale including the following:

- 1. The real estate will be transferred "AS IS".
- 2. The purchase price will be Twenty Three Thousand Dollars (\$23,000).
- 3. The Board of Education will retain the mineral rights to the property.
- 4. The Board of Education will provide gas to the property at no additional charge per the Oil and Gas Lease in existence between the Board of Education and BTI Energy.

**BE IT FURTHER RESOLVED** that it is hereby found and determined that all formal actions of the Board of Education of the Brookfield Local School District concerning and relating to the adoption of this resolution were adopted in an open meeting of the Board, and that all deliberations of the Board and any of its committees that resulted in such formal action were in meetings open to the public, when required by law, in full compliance with all legal requirements, including O.R.C. 121.22.

# **TRANSPORTATION CONTRACT**
