APPROVING CONSTRUCTION DOCUMENTS FOR THE ADDISON ELEMENTARY SCHOOL, BROOKFIELD MIDDLE SCHOOL AND BROOKFIELD HIGH SCHOOL DEMOLITION BID PACKAGE RELATED TO THE SCHOOL DISTRICT'S OHIO SCHOOL FACILITIES COMMISSION CLASSROOM FACILITIES ASSISTANCE PROGRAM PROJECT:

**WHEREAS,** BSHM Architects and Bowen & Foreman have prepared Construction Documents for the Addison Elementary School, Brookfield Middle School and Brookfield High School demolition bid package related to the School District's Ohio School Facilities Commission Classroom Facilities Assistance Program Project; and

**WHEREAS,** the Board has reviewed the Construction Documents and deems them proper in all respects.

**NOW, THEREFORE, BE IT RESOLVED** by the Board of Education of the Brookfield Local School District, Trumbull County, Ohio, that:

Section 1. <u>Approval of Construction Documents</u>. The Construction Documents referred to in the preambles to this Resolution are hereby approved in substantially the form presently on file with the Board of Education, subject to approval by the Ohio School Facilities Commission (the "Commission"). Failure of the Commission to grant its final approval shall cause the Board of Education's approval to become null and void.

Section 2. <u>Authorization of Bidding</u>. The Board of Education authorizes the commencement of the bidding process for the work referred to in the preambles to this Resolution in accordance with Ohio Revised Code Section 3313.46 and 3318.10.

Section 3. <u>Approval and Execution of Related Documents</u>. The President or Vice-President and Treasurer of this Board and the Superintendent, or such other School District officials as shall be designated by those officials, as appropriate, are each authorized and directed to sign any certificates or documents, and to take such other actions as are desirable, advisable, necessary or appropriate, to consummate the transactions contemplated by this Resolution.
