WHEREAS, the TCESC has presented an amended contract for the 2013-2014 school year in the amount of \$581,400;

RESOLUTION TO ALIGN WITH TRUMBULL COUNTY EDUCATIONAL SERVICE CENTER

Brennan moved and Martino seconded that the Brookfield Board of Education adopt the following resolution:

WHEREAS, Ohio Revised Code §3313.843 was amended by House Bill 153 of the 129th General Assembly in June 2011 to provide that the board of education of each city, exempted village or local school district with an average daily student enrollment of 16,000 or less, must enter into an agreement with the governing board of an educational service center, under which the educational service center shall provide services to the district [1]; and

WHEREAS, Ohio Revised Code §3313.843 was amended by House Bill 153 of the 129th General Assembly in June 2011 to provide that the board of education of a city, exempted village, or local school district with an average daily student enrollment of more than 16,000 may enter into an agreement with the governing board of an educational service center under which the educational service center shall provide services to the district [2]; and

WHEREAS, any agreement entered into under §3313.843 shall be filed with the Department of Education by the first day of July of the school year for which the agreement is in effect [3]; and

WHEREAS, the Brookfield Local School District Board of Education (hereinafter, the "Board of Education") has an average daily student enrollment less than 16,000; and

WHEREAS, the Board of Education desires to enter into an agreement with the Trumbull County Educational Service Center ("ESC") to be in compliance with Ohio Revised Code §3313.843 and to provide services delineated in the Agreement.

NOW, THEREFORE, BE IT RESOLVED by the Board of Education of the Brookfield Local School District that:

SECTION I: The Board of Education, in compliance with Ohio Revised Code §3313.843, hereby authorizes and approves the Agreement with the Trumbull County ESC for the provision of services. The District agrees to deduct from its State Foundation payments the amount of \$8.50 per pupil. Additional agreements may be entered into per ORC 3313.845 for shared services provided by the TCESC to the Board of Education. The effective date of this agreement is July 1, 2013. This agreement shall be effective until terminated by either the Brookfield Local Board of Education or the Trumbull County Educational Service Center by giving the other party written notice in advance of the termination date according to state law. Conditions of this agreement are subject to appropriate funding to the Trumbull County Educational Service Center to render said services.

SECTION II: IT IS FOUND AND DETERMINED that all formal action of this Board of Education concerning or related to the adoption of this Resolution was adopted in an open meeting of this Board, and all deliberations of this Board that resulted in such formal action were adopted in meetings open to the public, in compliance with all applicable requirements of the Ohio Revised Code.

EMPLOYMENT SEPARATION AGREEMENT RESOLUTION

WHEREAS, Mr. Hunkus agreed to an Employment Separation Agreement ("Separation Agreement") that would allow him to be voluntarily laid off with no right of recall or to future employment with the Brookfield Local School District.

NOW, THEREFORE, BE IT RESOLVED, by the Board of Education of the Brookfield Local School District, County of Trumbull, State of Ohio, that:

Section 1: The Board of Education adopts the Employment Separation Agreement as contained in Exhibit A. The Board authorizes the Superintendent and Board President to execute the Separation Agreement and implement its provisions.

Section 2: It is found and determined that all formal actions of the Board concerning and relating to the adoption of this Resolution were adopted in an open meeting of the Board, and that all deliberations of the Board and any of its committees that resulted in such formal action were in meetings in compliance with all legal requirements, including R.C. §121.22.
